# The St James Husborne Crawley Share Scheme

Many people have expressed a desire to help with our work to revitalise our church in Husborne Crawley and to bring it back in to being at the heart of our community. Some would like to see regular services return, some feel a sense of heritage, some have relatives who are now buried in its churchyard and others would like to see the building used for community activities. Whatever the reason, one way you can help is through fund raising. To this end we have come up with the St James Share Scheme (SJSS).

The St James Share Scheme is basically a lottery but is more fun and more rewarding than any national scheme. Ok, the maximum prizes in the national lottery are much greater but with the SJSS 40% is returned in prizes and you have a good chance of winning a prize. Furthermore, all the proceeds go towards our work of reviving your church, St James in Husborne Crawley.

#### **How it Works**

To join you agree to purchase 1 or more £5 shares each month. In return you are allocated a corresponding set of share numbers. At the end of the month all the share numbers are placed in the hat and the winners are drawn out by an independent guest. Typically, it would take place in the White Horse and be witnessed by the patrons. The results will then be published on our website; however you can elect to remain anonymous!

The monetary prizes are calculated so that for every 12 shares in the scheme one more prize is added (provided its value would be over £5\*). The prize pot is 40% of the total shares bought and the prize values are calculated so that first prize is at least half of the prize pot, second prize is at least a quarter, the third at least an eighth and so on.

When you sign up you will be given a reference code. You then set up a standing order to pay for your shares each month using the code as the transaction reference. Provided your payment has been received by the end of the month your share numbers will go into the hat for the prize draw. It's as simple as that.

### **Terms and Conditions**

- 1. The proceeds of this scheme are a donation to the church of St James Husborne Crawley; therefore members may join and leave the scheme at any time.
- 2. To qualify for entry into each month's prize draw, payment with the correct transaction reference must be received in the churches bank account by the end of that calendar month.
- 3. Any late payment will carry forward into the next month's draw.
- 4. Members of the scheme agree to provide us with their bank details and agree to receive their prize by electronic transfer.
- 5. The prize draw will take place in a public place during the first weekend following the end of the month. Typically, this would be in the White Horse, (time and date will be published on the website).
- 6. The winning numbers will be drawn out of the hat but an independent person (someone not in the share scheme)
- 7. We will endeavour to get new members joined as soon as possible.
- 8. The scheme complies with the requirements of the Gambling Commission and is registered with the local authority.
- Members of the scheme agree to the PCC keeping personal data such as names, e-mail addresses and bank details for the sole purpose of communication in connection with the scheme and for payment of prizes.
